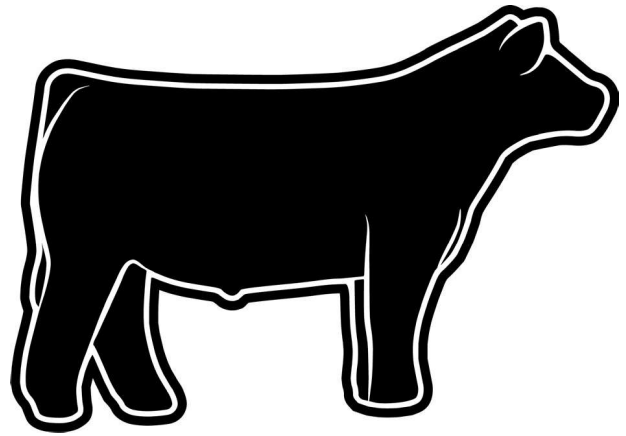

RULES

1. Beef, Dairy, Sheep, Swine, Dairy Goat, and Market Goat Grand Champion Showmanship winners for the current year will be invited to participate in the Showmanship Challenge.
2. Each champion will provide the animal for their area of achievement. Superintendents will also select an alternate animal to be kept at ringside in the event that the animal is becoming stressed during the contest. The judge of the individual species and show superintendent can ask that an animal be switched at any time during the contest for the safety and well-being of the animal being used.
3. Each participant will show all of the different animals during the contest.
4. Previous participants of the Showmanship Challenge may show another species in the contest, but they can only represent any species once. The Fair office will keep a running list of all participants and the species they have represented.
5. A judge will be selected from each department and that panel of judges will select the winner based on a point system.
6. Gifts and Prizes will be awarded.

RULES and REGULATIONS

1. All exhibitors must comply with General Rules and Regulations of the Montgomery County Agricultural Fair and Specific Livestock Rules.
2. Each purebred animal must be individually registered in their respective Breed Association. Any registered purebred animal that is not registered within the Angus, Hereford or Shorthorn breeds is eligible to be shown in the AOB Division. Registration papers will be checked on all purebred animals.
3. All entries must be made out in owner's name (not a farm name) as it appears on animal's registration papers.
4. All heifers must be the bona fide property of the exhibitor and registered with their breed association by July 1 of the current year.
5. 4-H Beef club members who are in compliance with all Montgomery County Beef Club requirements to sell will be allowed to present a maximum of 2 steers to be graded at the fair. In the event that one or both of these animals are deemed not finished enough for the sale, there will be no substitutions. The only case
